European Identity

Nationalism VS European

EU Social Integration

- "Contact Theory"

Theoretical Explanations

- In criminology, psychology, and sociology, the contact hypothesis has been described as one of **the best ways to improve relations among groups that are experiencing conflict**. Gordon W. Allport (1954) is often credited with the development of the **Contact Hypothesis, also known as Intergroup Contact Theory**

Meaning of Contact Theory

- **Equal Status:** Both groups taken into an equal status relationship,
- **Common Goals:** Both groups work on a problem/task and share this as a common goal, sometimes called a superordinate goal,
- **Acquaintance Potential:** The opportunity of group members to get to know each other as friends, and not merely as actors playing out social roles or as representatives of their social groups; the familiarity between group members involving the task or situation at hand
- **Support of authorities, law or customs:** Some authority that both groups acknowledge and define social norms that support the contact and interactions between the groups and members.

Theory & Practice: Requirements

According to Jan, European social integration can be defined as increasing levels of “mutual relevance between and cohesion among the different EU nationalities

Some EU experts Agreed Upon

- There are a variety of indicators for mutual relevance. Certainly, “exchange mobility” (Blau 1977), such as **intergroup marriage and migration**, is an indicator of strong ties.

- Other indicators aiming at face-to-face relations between Europeans are **transnational friendships, acquaintances** or, at a **low stage of involvement, cursory personal contact**.

- According to the theory, interaction reveals inter-group similarities and forges new ones, overcoming the differences and skepticism that engender conflict and violence (**Brown and Lopez 2001, 281**).
- Subsequent development of the contact hypothesis focuses less on Allport's emphasis of groups' "common humanity" and more on their relative status, authority, and goals (**Brown and Lopez 2001, 282**)..

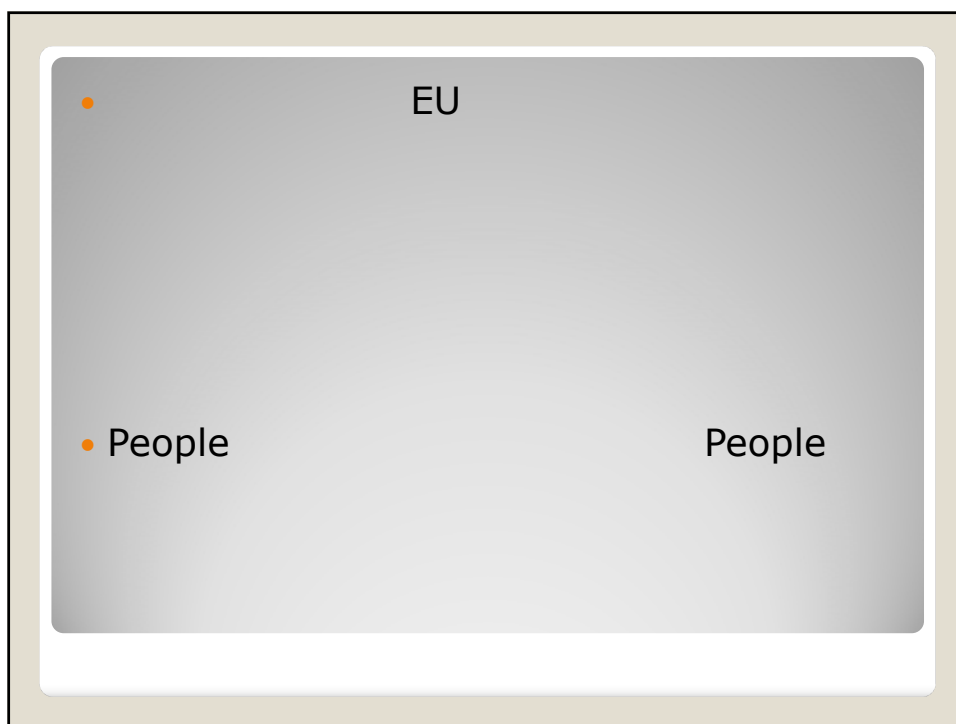
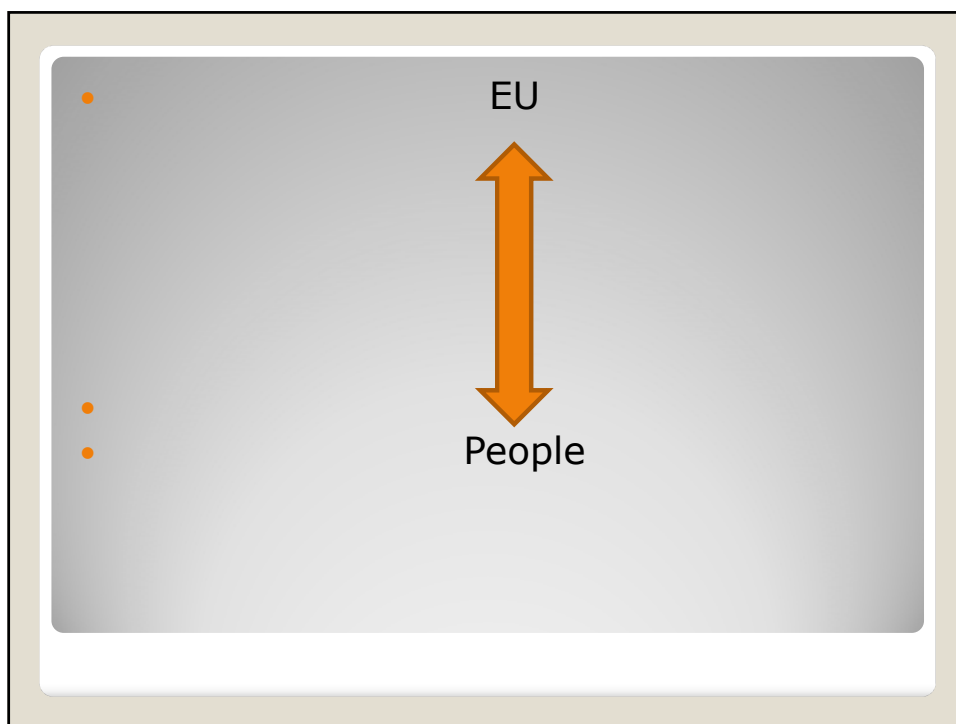

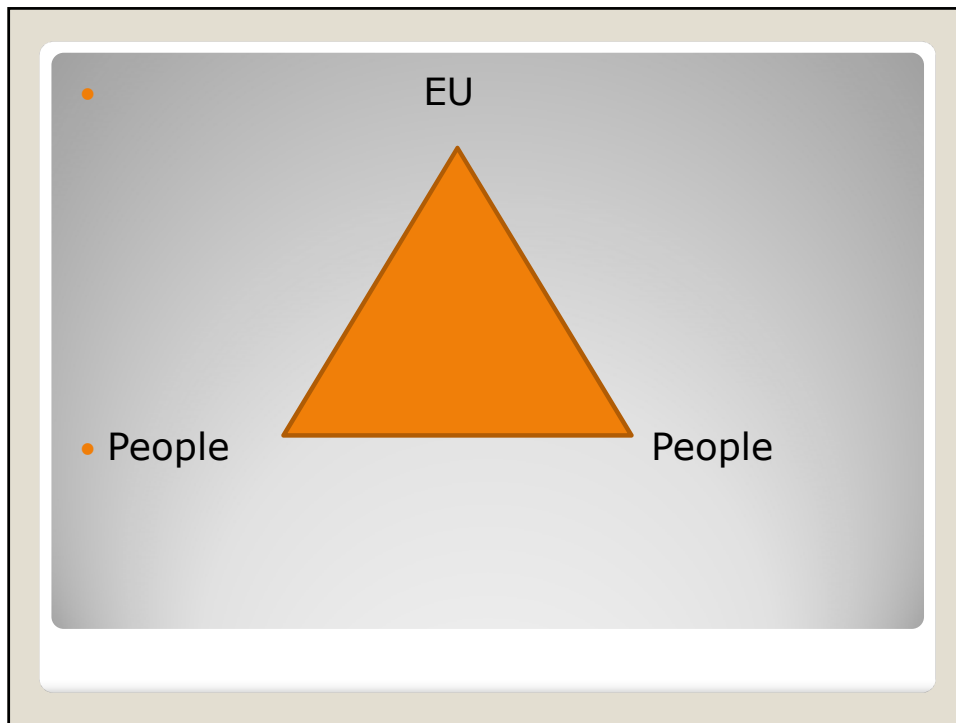
- It is argued that although it emphasized on contact between the citizens but it is not given any proper component to contact **between the European Level**. In other words, European social integration is a process that results from social policy-making and can be identified through the literal meaning of integration: to make parts into a whole. Therefore the EU would be socially integrated if its component societies had lost the geographical and legal boundaries to their social institutions and social practices, and functioned instead as 'a single social area'.
